Philosophy of Education

The handbook includes contact information for the school's leadership team, general information and specific policies and procedures, which if followed consistently, will contribute to the development of our community and the success of S.H.L.A.. Please keep this handbook in a place where it can be easily referenced. We reserve the right to periodically update the contents of the handbook.

POLICY OF DISCRIMINATION

S.H.L.A. does not discriminate on the basis of race, color, sex, creed, national or ethnic origin, physical disability, or sexual identity in the administration, hiring, educational policies, and other school-administered programs.

CONFIDENTIALITY

To ensure the respect and privacy for children, families and staff, confidential information will only be given to those required to know for the success of the school and our families. All staff, faculty and parents or guardians at S.H.L.A. are expected to respect the privacy of each child, family and staff member. All must maintain confidentiality with information that may come to them throughout the course of the day.

Access to each child's records will only be given to:

- Members of the permanent staff working with that child
- The Principal and Director
- The parents or guardians of the child

Information regarding children will be given to the following people only after WRITTEN AUTHORIZATION from the parent or guardian:

- Specialist working with a child in or outside of the school
- Office of the school where the child is or will attend

Students enrollment or attendance will not be given over the telephone if identity cannot be confirmed. Student's records will be kept for a minimum of 3 months after the child has left the school. Names, addresses, and phone numbers of parents, students or staff will only be given out with permission from the parent or legal guardian.

ENROLLMENT, TUITION & FEES

All fees are non-refundable and non-transferable.

Tuition

Kindergarten- 6th Grade - \$5,222.00 per year (\$522.00 X10 months, August-May) First month's tuition due by first day of school

Multi-Child Tuition Pricing

Second Child Discount - \$500.00 per year discount (\$50 off per month) Third Child Discount - \$700.00 per year discount (\$70 off per month)

Due at time of enrollment: \$400.00 Due monthly starting first day of school thru May 7th: \$522.00

Registration Fees

The registration fee is a one-time fee which is collected at the time of enrollment. The registration fee secures a spot for your child on a specific start date.

Curriculum Fees

The curriculum fee is a one-time fee which is collected at the time of enrollment. The curriculum fee allows us to gather all needed material and build out the schedule for the upcoming school year.

Application Fees

The application fee is a one-time fee which is collected at the time of enrollment. The application fee will go towards the admin cost of processing all paperwork.

Additional fees

Enrichment, Supply, Classroom, Placement tests (If applicable).

Re-enrollment

S.H.L.A. will invite current students to re-enroll for the next school year in March. Parents of currently enrolled students have two weeks to complete and return paperwork to secure their child's placement. Open enrollment for the public will begin April 1st. All enrollment fees will be due at the time of re-enrollment to reserve your child's place in S.H.L.A.. If fees are not paid by the 1st of April, you will then be considered as a new enrollee.

<u>Tuition</u>

Tuition is due by the 7th of every month. If not paid on the 7th, a \$30.00 late fee will be added per child to your tuition. If tuition and late fee are not paid on or before the 15th of the month, the child(ren) may not be able to return to school until tuition is caught up. If you have any questions or concerns about tuition payment, please contact John Mendoza.

Accepted Forms of Payment

S.H.L.A. accepts checks, cash, or online payments. All payments through the online portal will require you to cover the convenience fee for each transaction made. Receipts will be provided for all payments.

Discounts

S.H.L.A. offers sibling discounts. A sibling discount of \$500.00 yearly on tuition will be applied toward the second child. A third sibling discount of \$700 yearly on tuition will be applied.

Early drop off

S.H.L.A. will provide early drop off starting at 7:45 a.m.. Students are to be dropped off at the double doors that lead to the Sanctuary and will be escorted to the morning warm up areas.

Arrival and Drop off

S.H.L.A. will begin promptly at 8:30 a.m., all doors will be locked at 8:20 a.m.. Please try to have your child here no later than 8:20 a.m., allowing students time to get ready for class to begin. ALL STUDENTS NEED TO BE IN THE SCHOOL AT 8:20 A.M. ALLOWING CLASS TO BEGIN AT 8:30 A.M.. The beginning of the day sets the tone for the classroom. This eliminates any distraction during morning routines to start each school day and helps not only our day run successfully together, but your child to thrive in the prepared environment set up for them each day.

LATE ARRIVAL

Students arriving after 8:20 a.m. will need to be checked in through the foyer entry near the sanctuary. Communication is the responsibility of the parent/guardian if a child will be arriving late. If a child has more than 3 late arrivals in a 10 week period, a parent/principal meeting will be scheduled to discuss how we can assist to remedy any issues on our end.

LATE pick up after 3:15 p.m

If your child is picked up later than 3:15 p.m., your child will be escorted to the late pick up area of the foyer near the sanctuary. A late pickup fee of \$6.00 daily will be added to your account and expected to be paid at the time of the next month's tuition. Late pick up fees for the month of May will be due by the last day of school.

Important: In case of emergency or hardships, it is the responsibility of the family to notify the Principal.

Study Hall/Late Pick Up 3:15-4:00 p.m.

S.H.L.A. offers study hall/late pick up for students for a charge of \$6.00 per day, not to exceed \$90.00 per month. It is the responsibility of the parent/guardian to communicate when this resource is to be utilized with no less than 24 hours notice of any changes.

<u>Dismissal</u>

S.H.L.A. reserves the right to discontinue care for any student. These decisions will be made based on the child's ability to succeed in the environment. Furthermore, if the student presents a danger to him/herself, the teacher, staff, or the other students or if their needs are out of the range of what S.H.L.A. is able to provide; we reserve the right to ask the family to make alternative arrangements.

Additionally, S.H.L.A. may terminate your child's enrollment under the following circumstances:

- Parents do not agree or do not follow and comply with the policies set forth in this Handbook/Statement of Faith.
- Lack of parental cooperation with S.H.L.A.'s efforts to resolve differences and/or to meet the child's needs through parent/staff meetings or conferences.
- Inappropriate or abusive behavior and/or verbal abuse or threats by parents, relatives, guardians or other parties toward the staff of S.H.LA., other parents or children.

Withdrawal

A thirty-day written notice is required to withdraw your child otherwise the following month's tuition will be due.

Early drop off 7:45 a.m. - 8:20 a.m. Monday Teachers available by phone (Prep day) 8:00 a.m. - 4:00 p.m. Tuesday - Friday 7:45 a.m. - 4:00 p.m. <u>Dismissal</u> Kindergarten 3:15 p.m. Elementary 3:15 p.m.

<u>Breakfast</u>

Students will be allowed to eat a parent provided breakfast from 7:45 a.m. - 8:20 a.m.. Food will not be allowed after 8:20 a.m. until snack time later in the morning.

Sign In/Out

S.H.L.A. requires all students to be checked in/out daily. Teachers will be required to sign their student in/out on the paper sign in/out sheet daily. Your student(s) must be signed in to the school and signed out before they are picked up.

Absences

No refunds will be given for absences due to illness, vacation or school closings. **Regular** school attendance is extremely important.

STUDENT LIFE

<u>Food</u>

Snacks and lunch <u>are not provided</u> by S.H.L.A.. Parents will need to provide their child with a snack and cold lunch daily. **Please have all lunch boxes, containers, utensils and cups labeled with your child's name;** as these items can easily be lost or misplaced in a group setting. **Please avoid sending highly processed, sweetened snack foods that have little to no nutritional value. It's our desire to encourage healthy eating at school.**

<u>Allergies</u>

Any food allergies such as peanuts, eggs, wheat, milk, etc., must be listed on your child's admission form located in your enrollment packet, there must be an Allergy Emergency Plan

from your child's physician on file. All changes regarding food or allergy restrictions must be put in writing and given to administration. Administration will post this information in an area of the class room so all staff members have access to it.

Classroom Size, Teacher to Student Ratio

S.H.L.A.'s teacher/student ratio for K4-6th grade will have one teacher per classroom with up to 12 students with a shared aid per two classes. S.H.L.A. promotes healthy growth and development in each class by low student/teacher ratios.

Personal Items

Toys and stuffed animals of any kind may not be brought to school, unless specifically requested by the teacher. Toys brought to school will be placed in the student's backpack till the end of the day. Please do not allow your child to bring toys from home. S.H.L.A. provides many activities throughout the day and a toy from home can be a distraction.

Clothing Policy

S.H.L.A. does not have a uniform dress-code, however, your child's clothing should be appropriate. Neat, conservative dress will be required for both boys and girls. A parent may be called to bring an appropriate change of clothes, if deemed necessary by S.H.L.A.

Girls - May wear dresses, skirts, pants and modest shorts with tops that cover the midriff. No tank tops. Shorts should be worn under their dresses and skirts.

Boys - May wear pants and modest shorts with appropriate tops. No tank tops.

Dress Code

- Jewelry: no excessive or showy jewelry
- Accessories must not be distraction or ostentatious as determined by the administration
- No hats
- No visible temporary tattoos
- Boys no earrings, studs or visible piercings are allowed
- Hair length, color, and style must be in good taste, clean and well groomed as determined by the administration
- Inappropriate accessories are subject to confiscation.

Please provide: Clearly label with your child's name

- Backpack labeled with your child's name, and large enough for a folder. No small backpacks please.
- Lunch box- labeled with child's name

Lost and Found

All lost and found items will be in the Principal's office. Lost and Found will be regularly cleaned out and any items left will be donated. Please try to check the lost and found if your child is missing items.

Outdoor Play

S.H.L.A. students will have no less than one half hour of outdoor play time daily, weather permitting. On inclement weather days, students will engage in physical activities inside the classroom or in the indoor children's sanctuary as a substitute for outdoor play.

Transportation

S.H.L.A. does not provide transportation for children.

School closings

If severe weather conditions make travel hazardous, school may be postponed, closed early or canceled. S.H.L.A. will inform parents of school closing through the parent messaging system, Facebook, etc..

Communication

Open communication is imperative for the students, families and S.H.L.A.. We want to have a solid foundation in our relationships with our students and families. We strive to have friendly yet professional relationships with all families at S.H.L.A.

Changes in Child's Information

As part of the admissions process, all parents/legal guardians are required to furnish information about their child and others who are authorized to make decisions. Please notify the office, **in writing**, of any changes that may occur during the school year. These changes include but are not limited to: marital status, address, cell phone, or home numbers, email, employer, contact names, child's living arrangements, and child's health including newly administered immunizations, speech/hearing test results, professional evaluation results/recommendations, allergies, and authorized persons allowed to pick up your child

Custody

The school will require a copy of any court mandated custody agreements in the event custody for a child's parent or legal guardian is modified or restricted.

Open Door Policy

Open communication between staff members and parents is essential. If, at any time, questions or concerns arise, we urge parents to bring these to the attention of the classroom teacher or the administrative staff. Informal conferences or conversations are encouraged and may also be scheduled with teachers or school leaders at any time throughout the year. S.H.L.A. is an "open door".

Teacher Notes

If at any time you wish to have a conference with your child's teacher, please email the Principal at <u>Servantsheartleadership22@gmail.com</u> or write the child's teacher a note and send it with them in their folder. Please do not try to have a conference with the teacher during drop off or pick up. This keeps the teacher from focusing on her class and may be a safety concern.

<u>Calendar</u>

S.H.L.A. 2024/2025 calendar is posted on our website: <u>www.servantsheartleadership.com</u>. We encourage our parents to visit S.H.L.A.'s website, social media pages, and parent messaging system to remain aware of upcoming events, closings for holidays and announcements. The calendar will be placed in each child's folder. Extra copies of the calendar will be available upon request.

The Child's Health

Necessary Health Information

Students will not be able to attend school until we have the necessary forms on file, including:

- Authorization for Emergency Medical Attention
- Emergency contact form
- Allergies/Special attention needs

This information will ensure we have the information necessary to handle any emergencies involving your child expeditiously. Please be sure all forms are up to date at all time; especially with parent phone numbers where parents can be reached.

Incident/Accident Reports

In the event your child is seriously hurt at school, you will be immediately contacted at the numbers provided on your emergency authorization card. If your child sustains a minor injury at school, we will administer first aid and prepare an accident/incident report with detailed information of the injury and care given. Parents can expect a phone call to inform you of the incident. Accident/incident reports require a parent's signature at the time of pick up acknowledging the notice. If you have designated another adult to pick your child up from school, he or she will be asked to sign the report and he/she will be responsible for communicating its contents to you. You may, however, speak to your child's teachers to discuss the contents of the report via a scheduled meeting. You will be provided a photocopy of the report; the original will be kept in your child's file.

<u>Illness</u>

In order to maintain the healthiest environment possible for all children at S.H.L.A., we ask children who are feverish or not feeling well to be kept at home for the day. However, the child's pediatrician may provide a doctor's note stating the child is not contagious and is healthy to attend school. If the child develops symptoms of illness while at school, the parents will be

notified. The child will be removed from the classroom environment if the child develop the following:

- Symptoms requiring a greater need for care than staff can provide without compromising the health, safety, and supervision of the other children.
- Symptoms preventing the comfortable participation in activities.
- Oral temperature 100.4 degrees or greater; Armpit temperature 99.4 degrees or greater; accompanied by behavior changes or other signs or symptoms of illness until medical evaluation indicates the child be included in S.H.L.A. activities.
- Symptoms and signs of possible severe illness such as lethargy, diarrhea, vomiting, a rash with fever, wheezing or behavioral changes until medical evaluation indicate the child can be included in S.H.L.A. activities.
- The child has been diagnosed with communicable disease should stay home until medical evaluation determines the child is no longer communicable and is able to participate in school activities. A list of communicable diseases is found at the end of the handbook. Any child who had one of the listed diseases needs a health professional's note of health to return to school. Children sent home exhibiting such symptoms must be symptom free for a minimum of 24 hours prior to returning to school or return to school with a doctor's note indicating that they are not contagious and healthy to attend school. We reserve the right to require that your child be picked up if he/she is unable to function in the classroom setting due to illness or injury, out of respect for your child and their classmate.

Prescription Medication

If your child requires prescription medication, please discuss this with your doctor. If possible, obtain medication that can be given at home. If it is necessary for your child to have medication administered during school hours, please fill out a **Medication Authorization** form at the school. All medications will be given by the Principal or Director. School staff will not administered medication without written authorization from a parent. **Medication will not be administered through a child's food.**

All medication must be delivered to the school Principal or Director in the original container, labeled with the child's name, a date, dosage directions for administering, the physician's name, and a pharmacy name. The school will administer the medication only as stated on the label instructions or as amended by the child's physician. S.H.L.A. <u>cannot administer expired medicine.</u>

Non-Prescription Medication

S.H.L.A. will dispense over-the-counter medication such as Tylenol, Ibuprofen, ointment/creams to children at the verbal request of parents for minor symptoms; however, a doctor's note will be required for recurring symptoms, "as-needed" circumstances, or if the parent request for the child to receive over-the-counter medication for more than two consecutive days. The school will

follow all instructions listed on the over-the-counter medication including instructions for age ranges and dosage. If the medication does not already contain a dispenser, we ask that parents provide the dispenser cur or dropper.

Emergency Care

In the event of a life-threatening accident, the staff will call 911 and render aid as appropriate. Parents will be notified as soon as the emergency has been reported. In the event of any medical situation that requires immediate medical attention, we will want your child to see a doctor immediately. It is critical that S.H.L.A. reach you during the school day.

Not Able to Reach Parent

If your child needs immediate medical attention, and you cannot be reached, your emergency contact can authorize us to seek medical care in your name. We will have your child transported to a local emergency room while we continue our efforts to contact you.

Child Abuse/Neglect

Child abuse and neglect is against the law and so is the failure to report it. Abuse is defined as mental, emotional, physical or sexual injury to a child or failure to prevent such an injury to a child. S.H.L.A. policy is all faculty, administrators and staff share the responsibility of preventing and reporting of suspected child abuse and sexual molestation.

What is Child Abuse?

- Child abuse consists of any act of commision or omission that endangers or impairs a child's physical or emotional health and development.
- Child abuse includes any damage done to a child which cannot be reasonable explained, which is often represented by an injury or series of injuries appearing to be non-accidental in nature.

Child Abuse Prevention Guidelines

- Never discipline when you are angry
- Get to know your child's friends
- Never leave a child unattended
- Be aware of changes in a child's behavior or attitude
- Listen to them and believe what they say
- Be alert for any talk that reveals premature sexual understanding
- Teach a child correct name of body parts
- Ask questions

<u>Smoking</u>

S.H.L.A. is a smoke-free/vape free environment; smoking/vaping is not permitted in or on campus.

Emergency Preparedness/Fire and Safety Drills

S.H.L.A. strictly adheres to the Emergency Preparedness Plan as stated below:

- Fire drills are conducted each month
- Severe weather drills are conducted at least once every three months

Parent Communication

Parents will be contacted as soon as their children are relocated to the Alternative Evacuation Location.

<u>Safety</u>

For the safety of the students, families, and visitors, S.H.L.A. requests that all individuals within the facility follow the policies of the school. These policies include but are not limited to the following:

- Staff and students will walk in the hallways
- Staff and students use inside voices
- Students are not allowed to exit the building without their parent or authorized pick-up
- Exit doors should be opened by adults only
- Parents shall carefully supervise children in the parking lot
- Cell phone use is prohibited during morning drop off and afternoon pick-up times

Behavior Management:

Underlying Principles

- We respect ourselves and other people
- We are careful with our own work and our friends' work and belongings
- We keep our surrounding and ourselves clean

By setting appropriate and consistent limits to behavior, we provide a secure environment in which children can explore their physical and social world.

Discipline is instructive when:

- It supports self-esteem and allows children to feel capable, competent and pleasant with others
- It takes into account a child's developmental level of understanding and ability
- It changes a child's behavioral needs (there is change and growth)
- It acknowledges caring, cooperative, desirable behavior
- It guides, gives simple explanations, and offers alternatives so that a child can make choices. In time, this will aid the making of appropriate choices
- It is consistent
- It is based on self-discipline and self-control

Setting limits helps children to:

- Feel secure and orient themselves in the world
- Find appropriate expressions for feeling that are hard to control
- Initiates the joy of lifelong learning

Prevention:

- Knowing the children: this helps to tailor disciple instructions for each child
- Prepared environment: this helps to facilitate freedom of movement
- Awareness of transition time: teachers help children move from one activity to another without disruption
- Modeling good behavior: this sets the example for the children

If Prevention does not work

- Try first to distract or defuse the situation, giving children a release
- Use "do's" (rather than don'ts) and give brief explanations
- Respond in a calm but firm manner, indicating what is expected from the child and what choices the child has
- Help the child to realize the consequences of his or her actions
- Follow through with consequences
